Audited Financial Statements for Fiscal Year Ending June 30, 2022

Auditor Dave Robydek of CliftonLarsonAllen LLP presented and reviewed the audited financial statements for fiscal year ending June 30, 2022. He gave a clean, unmodified opinion; no compliance or internal control deficiencies were identified, even with new rules in place this year.

Staff summarized the management discussion and analysis and responded to questions. The committee was pleased to hear that the audit went smoothly, and The committee asked for a couple of minor adjustments to the report. The committee requested that the phrase “decrease in net position” should be changed as it’s not a decrease.
